

PRIVACY STATEMENT ON THE PROCESSING OF PERSONAL DATA FOR BROWSING THE WEBSITE

This page describes the management of the site with reference to the processing of the personal data of its users.

The Privacy Statement is only provided for the Company's website and not for other *websites* that the user may consult through *links to external addresses*.

The Privacy Statement is also inspired by [Recommendation no. 2/2001](#) that the Group of European data protection authorities established by [Article 29 of Directive no. 95/46/CE](#), adopted on 17 May 2001 to identify certain minimum requirements for the collection of personal data *online*, and in particular the methods, timing and nature of the information that Data Controllers must provide to users when they connect to *web*, pages, regardless of the purpose of the connection.

THE DATA CONTROLLER

After consulting this site, data relating to identified or identifiable persons are processed; by accessing the site, the user consents to the collection and use of their data according to the terms and conditions set out in this Privacy Statement.

The Data Controller is Candiani Spa, with registered office at Via Arese, 85 - 20020 Robecchetto con Induno (MI), Italy.

LOCATION OF DATA PROCESSING, CONTROLLER AND PROCESSORS

Processing connected with access to the site takes place at the aforementioned registered office of Candiani Spa and is performed by technical staff responsible for processing, as well as by anyone carrying out occasional maintenance operations.

No data from the web service is communicated or disseminated.

The dispatch of electronic mail to the addresses indicated on this site involves the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data included in the message. TYPES OF DATA PROCESSED

Browsing data

The computer systems and *software* procedures used to operate this *website* acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

This information is not collected to be associated with identified entities, but through processing and association with data held by third parties, could by its very nature allow users to be identified.

This category of data includes IP addresses or domain names of computers used by users connecting to the site, the *URI (Uniform Resource Identifier)* addresses of requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response from the *server* (successful, error, etc..) and other parameters regarding the user's operating system and computer environment..



These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing (or are stored in accordance with the law). The data could be used to ascertain responsibility in the event of suspected computer crimes against the site: except for this eventuality, *web* contact data are not currently stored for more than seven days.

Cookies

The site acquires no personal user data.

No use is made of *cookies* to transmit information of a personal nature, nor does the site use so-called persistent *cookies* of any kind, or systems for tracking users..

The use of so-called session *cookies* (which are not permanently stored on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers (consisting of random numbers generated by the *server*) necessary to enable safe and efficient exploration of the site.

The so-called session *cookies* used on this site do not use other computer techniques that could potentially compromise the confidentiality of user browsing and do not allow the acquisition of the user's personal identification data.

OPTIONAL DATA PROVISION

Subject to the specifications made with regard to browsing data, the user is free to provide their personal data through the site. Failure to provide such may entail the failure to obtain what has been requested.

PROCESSING

Provided that no personal data are collected (except to fulfil requests received by email see Privacy Statement at the link <http://candianidenim.it/#!/?DataManagement> specific security measures are taken to prevent the loss, illegal or incorrect use of data and unauthorised access to data.
